In accordance with Rule 28.14 of the Agreement between the State of Alaska and the Inlandboatmen's Union of the Pacific, the Alaska Marine Highway System is publishing the following vacant position listing. Employees wishing to bid on vacant position(s) must submit a Job Class Application and a Bid Preference Form. Bid preference forms are not held over from one vacancy listing to another.

Employees will have until **March 2, 2012** to submit their Job Class Application and Bid Preference Form. Submissions must be received at the AMHS Ketchikan Central Office at the above address by the close of business (4:30 PM) on **March 2, 2012**.

Reminder: Withdrawal of bids must also be submitted by the closing date.

These vacancies will be awarded on or around **April 2, 2012** with an implementation date of approximately May 12, 2012 or as soon as possible thereafter, in accordance with Yard manning needs and RIF Dispatching.

- Submit:**
  - A Job Class Application if you have not yet been approved for the Job Classification of interest.**
  - A Bid Preference Form to indicate the order you prefer of the various positions for which you would like to be considered.**
  - A Nepotism Waiver – only necessary if you are related to or in a conjugal relationship with another AMHS crew member.**
  - Attach only those training items listed in the Minimum Qualifications that you have not previously sent in to AMHS.**
- Items that **must be attached** if listed in the MQ's include: current **Drivers License**; current **performance evaluations written within the past 6 months**; a **résumé** if experience outside AMHS is to be considered; **job shadowing** documents. This applies to all submissions including **Downgrades, Laterals and Transfers**.**
- Minimum Qualifications for all positions were effective June 16, 2007. Copies of all MQ's are available from the Pursers on the vessels or by contacting AMHS Dispatch Office.**
