In accordance with Rule 28.14 of the Agreement between the State of Alaska and the Inlandboatmen's Union of the Pacific, the Alaska Marine Highway System is publishing the following vacant position listing. **Employees wishing to bid on vacant position(s) must submit a Bid Preference Form during the open bidding period.** Bid preference forms are not held over from one vacancy listing to another. Please utilize Bid Preference Form version dated: 1/4/2016

Employees will have until **March 1, 2019** to submit their Bid Preference Form. Submissions must be received at the AMHS Ketchikan Central Office at the above address before the close of business (4:30 PM) **March 1, 2019**. **Withdrawal of bid submissions or changes to preferences must also be submitted by the closing date above.**

These vacancies will be awarded on or around **April 1, 2019** with an implementation date of approximately April 20, 2019 or as soon as possible thereafter, in accordance with Yard manning needs and RIF Dispatching.

2. Submit:
 - A Bid Preference Form for Unlicensed Vessel Positions to indicate the ranking order of the various positions for which you would like to be considered. Include a copy of any Minimum Qualifications not previously submitted to and on file with AMHS Training office. Certificates previously submitted do not need to be attached as they are retained in our Dispatch/Training database.
 - A Nepotism Waiver – only necessary if you are related to or in a conjugal relationship with another AMHS employee.
3. **NOTE: Minimum Qualifications for all unlicensed positions have been revised & became effective January 1, 2016.** Copies of all MQ's are available from the Pursers on the vessels, posted on the AMHS Internal Resources website at: <https://web.dot.state.ak.us/amhs/resources/mqs.shtml> or by contacting AMHS Dispatch Office.
4. **NOTE: MQ's must be met for all bid submissions including Downgrades, Laterals and Transfers. Items that must be attached (if listed in the MQ for the position on which you are bidding) include: current performance evaluations; a résumé if experience outside AMHS is to be considered; job shadowing documents. Please review the MQ's prior to submitting your bid.**
