Dear Sisters and Brothers,

We have had some questions from members recently about whether they can reach out to the Union about issues at work. Yes! It is your legal right to talk to the Union about working conditions, and you should always feel free to talk with us about any work issues you are concerned about. You can also forward IBU any communications you receive from AMHS that you would like to discuss with us. We are here to answer your questions and to make sure AMHS is correctly following the Master Agreement that protects your rights.

You should also know you have a right to ask for a Shop Steward to attend any meeting that you believe may result in discipline or may be used to gather information that will later result in discipline. If you do not know who the Shop Steward on your vessel is, you can always contact the IBU and we will tell you.

The best way to contact the Union is through a telephone call, or an email from your personal (non-work) email address.
